Accordingly, UGC invites fresh applications from all eligible Higher Educational Institutions (HEIs) as per University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 for offering Open and Distance Learning (ODL) programmes and Online (OL) programmes from 2020-21, academic session beginning January, 2021 and onwards. **The online portal for submitting applications shall be opened upto 15.10.2020.** The duly certified hard copy of the application along with annexures should reach DEB office of UGC at 35, Feroze Shah Road, New Delhi-110 001 within 10 working days of submission of online application.

HEIs already recognized by UGC for offering ODL/Online programmes including the academic year 2020-21 and eligible as per the UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 may apply for additional programmes, if any.
